All Junior Handlers: (under18 years of age) will receive a dog toy.

Event and classes will go on Rain or Shine - Dress for the Weather.

BRING: Water and Shade for your dog(s) and chairs for yourself.

Please clean up after your dog(s) and treat the farm property and livestock with respect as well as the motel.

Lock your vehicle and do not leave dog(s) unattended.

Rabies vaccination is mandatory. The farm management requests proof of current rabies vaccination. Expulsion from the grounds may ensue if such proof is not furnished upon request.

In an effort to make sure that we are able to complete this trial during daylight hours, here are some of the changes that we've made and that you should take note of:

The Trial Course handlers meeting with each judge will include all three levels and the course will only be walked ONCE. Therefore, the handler's meeting for the ranch course at the conclusion of JHD will include ALL entrants in that trial. There will be an opportunity to ask the judge questions before the start of each class. The meeting for the afternoon ranch course will also be all classes together, before the start of the first class that will be the only time the course is walked. ALL entrants must be ready to walk on the field as soon as the gate handler notifies them.

No runs will be delayed because of a conflict in another class. The run may be run at the next available opportunity. The first trial course judge will take a lunch after the class is completed and the next trial course will begin immediately after, the trial won't stop for lunch - please take a break at your convenience.

1st tiebreaker will be based on points for the outrun/lift. 2nd tiebreaker will be based on points for the Round Pen exercise. 3rd tiebreaker will be based on time elapsed.

HRD III

Course Description:

1. 5 sheep will be set out with grain (free standing)
2. Handler will send dog on an outrun from post "C" (handler walks up to post A during outrun and lift), lift sheep and fetch them to handler, bringing the sheep to top of runway at A.
3. Dog will drive sheep thru runway chute. Handler may move along runway to assist.
4. Drive sheep to and through Z chute to hold area at Gate 1. Handler to remain at end of runway until sheep are at the Hold area.
5. Handler joins stock and dog at hold area. Handler assists dog with putting sheep through the pasture gate and remains at gate while dog drives sheep to Gate 2 in sort area.
6. Handler will enter the Round Pen with his dog and the stock and proceed to split off 3 marked sheep and then drive those 3 sheep to the designated area (approximately 73 feet from the Round Pen) where some feed has been placed. Leave sheep to settle, dog to be called back to handler and then sent to regather. Reopen the three sheep in the Round Pen.
7. Take sheep out of round pen and drive sheep through maltese cross, as shown on diagram to gate. Handler may accompany dog to maltese cross, but stay at maltese cross until sheep are driven to Gate 3.
8. Take sheep to shed area through drive panels and shed two sheep from group, using the fence line (will be marked). Proceed to reopen and pen sheep.

HRD II

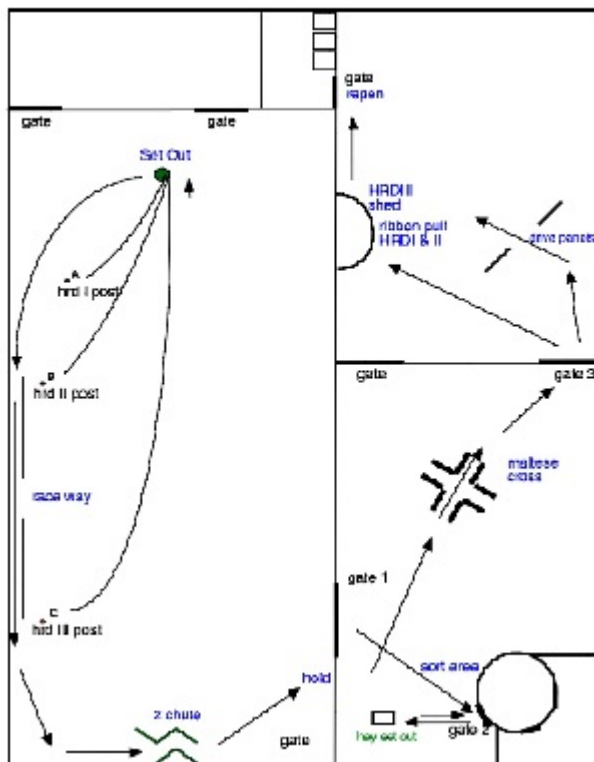
Course will be the same as for HRD III with the following exceptions:

1. Handler's post will be as indicated on the attached drawing.
2. In sort exercise, sheep will not be marked and the handler may fetch or drive sheep to set out. Handler must still leave sheep with dog and return to pen gate and then send dog to bring sheep to the pen. Instead of shedding two sheep, the handler will be required to hold the sheep in the marked area and remove a ribbon from a sheep.

HRD I

Course will be the same as for HRD II with the following exceptions:

1. HRD I will fetch entire course. Handler's post will be as indicated on the attached drawing. Handler may move halfway between the HRD I post and the sheep set out to send the dog on the outrun,



Course time will be 14 minutes.
