Transfers (formerly Move-ups)

- After a dog earns a title, a transfer (i.e., from an obedience class to an obedience class or a rally class to a rally class) may be requested if, according to the owner's records, the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made.
- The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial.
- Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

For a written request regarding a transfer for an ineligible dog and handler team from the "A" class to the "B" class at the same level, please refer to the AKC Obedience Regulations, Chapter 1, Section 16b

TRIAL SITE INFORMATION

Turn west on Sligh Ave. Continue 2.8 miles on Sligh which turns slightly south and becomes Lambright St. Turn left on Garsh Loop, just after the light on Himes Ave. (just before Dale Mabry Hwy) between Big G's Pizzeria and Sportseast Player Development. The DTCT Building is behind Sportseast.
